## NON-RESIDENT MEMBERSHIP

Anyone that has their primary residence outside a (fifty) 50 mile radius of the club may submit application for a Non-Resident membership. A proof of primary residence (voter registration card, property tax receipt, or driver's license) must be submitted with the application. The Board of Directors will approve all new applications for this membership category.

The Non-Resident pays an initiation fee of \$400 plus an annual fee of \$600, payable by the membership anniversary date. Proof of primary residence (as described above) must accompany the yearly dues. Failure to submit the yearly dues and required documents by the 15<sup>th</sup> of the month following the member's anniversary date will automatically terminate the membership.

The Non-Resident membership is a non-voting membership that has the same privileges of a full membership, except pays a reduced Green Fee each time playing golf.

These members are also eligible to participate in all club tournaments provided they maintain a SCGA Handicap here at CCL. The only restriction for Non-Resident Members with regards to tournaments will be signing up for the CCL Member-Guest. Full golfing members will have priority for this one event. However, Non-Resident members will be allowed to play if the field is not full by the sign up deadline.
